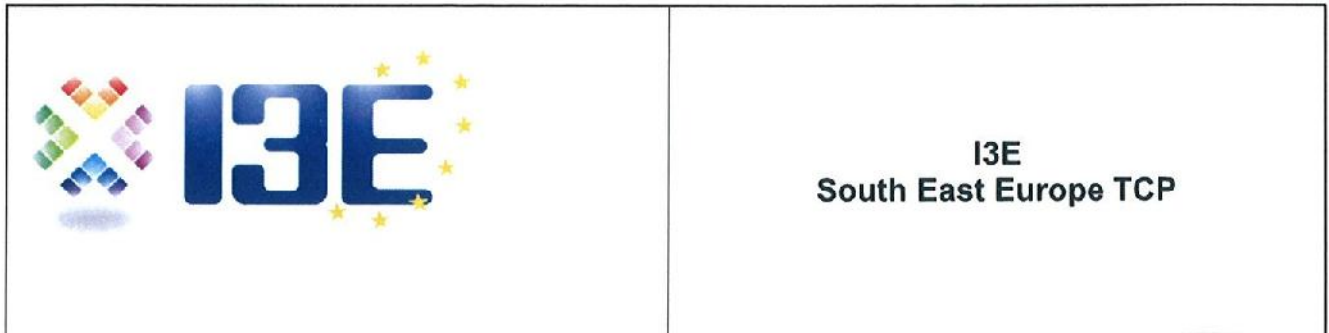

The title of the meeting was " The importance of innovation management in companies" and had as object the development of the innovation in the embedded systems and industrial informatics fields.

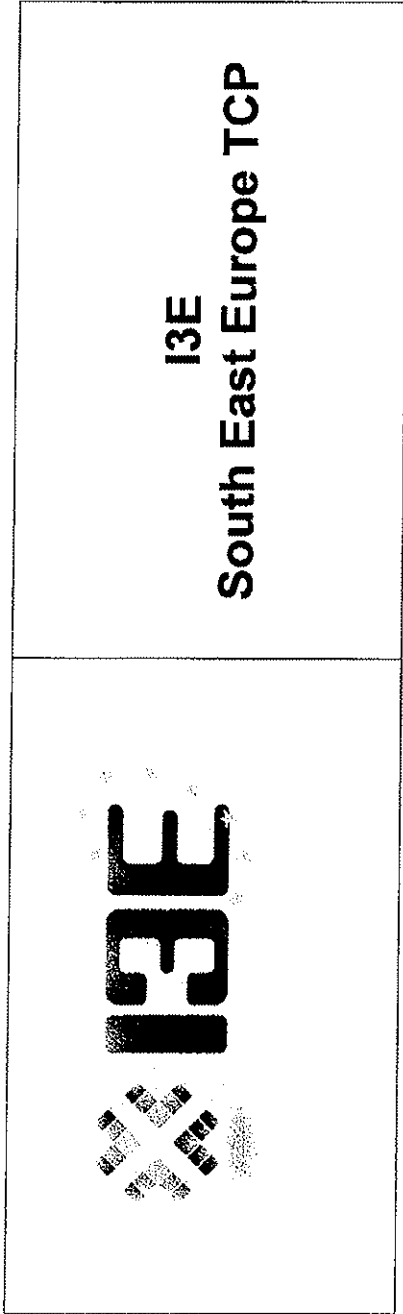
The main topics discussed with the stakeholders were:
